Message from the Foundation

One of the particularities of a biennial report is that is allows one to take stock of how fast the world has changed: mounting geopolitical tensions, exponential technological progress, short- or long-term consequences of the climate crisis, to name just a few. Our Foundation, and philanthropy more generally, are in not immune to the pressures these changes imply.

Every donor, whether in response to a funding request or of their own initiative, aspires to contribute in their own way to a better world by supporting initiatives that tackle the many urgent challenges of today. That, it turn, raises questions about timing: is it better to give in during one's life or after death? For a specific time or indefinitely?

As an older donor remarked to us when creating her fund: "Rather than the promise of infinite time, isn't eternity the lasting impact that our giving has for beneficiaries?" Our role is not to take decisions for philanthropists but to help them clarify their motivations and orient their generosity and its impact so as to better structure their giving.

Three out of every four francs entrusted to Swiss Philanthropy Foundation during the past 18 years have been disbursed as grants to projects in Switzerland and abroad. Experience has taught us that philanthropists want to make a difference in the "here and now" by engaging actively in organizing their philanthropy. For donors in later life, this can take the form of a testamentary fund, demand for which has been steadily growing.

Lastly, we invested in digitalizing our internal processes, in large part thanks to support from our partners. Our Board enhanced its diversity with the nomination of several new members. We continue to promote donor collaborations, exemplified by the innovative Demaimpact initiative, which empowers young people to support projects by and for youth. This report provides an overview of our many activities and initiatives.

We are deeply grateful for your faithful support for, or your recent interest in, the activities of our Foundation. We hope you enjoy reading this report and look forward to meeting you soon at our offices on Place Cornavin.

Contributing to a better world

Philanthropy is becoming increasingly professional. We believe this is a good thing. Indeed, running a private foundation requires rigorous attention to administration and accounting, as well a duty to verify that grants are used for the intended purpose. Founders and their advisors too often underestimate the importance of these tasks.

Since 2006, Swiss Philanthropy Foundation has played a key role in the philanthropy sector by empowering private and institutional donors to adopt a rigorous, committed approach to their giving. We act as a platform to facilitate philanthropic initiatives and donations in Switzerland, Europe and around the world. We also support beneficiary organizations though funding, capacity-building, and networking.

Access to simple, effective solutions that facilitate philanthropic giving, such as hosted philanthropic funds, while essential, does not on its own drive people to give. Another facet of the Foundation's work, therefore, is to develop innovative programmes that encourage everyone to take the first step on their philanthropic journey and to sustainably achieve their goals.

As a foundation independent of any financial institution, Swiss Philanthropy Foundation is governed by the Foundation Board, with the support of the Bureau and the Financial Committee, which collectively ensure that the governance of the Foundation meets the highest standard of integrity. On the operational side, a team of ten staff manage a range of projects with unfailing professionalism and agility.

Bespoke giving Personal philanthropic funds

Personal philanthropic funds offer bespoke solutions that adapt to the donor's individual motivations and enable them to realize their philanthropic goals. We help donors target causes or projects they are passionate about, ensure their giving make a difference for society and achieves a lasting impact, and unite their family around shared philanthropic values.

Three questions to a personal philanthropic fund donor

- What does philanthropy mean to you?
 "Philanthropy is motivated by a desire to have a lasting, positive impact on society by supporting organizations dedicated to social equality and progress. Our heart drives us to give, but our aim is to translate this impulse into a set of strategic, professionally executed actions. We also want to leverage our impact by working with other families
- Why did you set up a hosted fund with Swiss Philanthropy Foundation?
 "Because it was the most modern and efficient solution out there in our view. We get to focus on our giving strategy and let the experts worry about the administrative side of things. The speed and simplicity of the set-up process was also a major positive point for us. Lastly, we liked the idea of working with other philanthropists to leverage our impact. The first project we supported was co-funded with another fund hosted by Swiss Philanthropy Foundation."
- In what way is Swiss Philanthropy Foundation a partner for your fund?

 "Thanks to the hosting foundation, we always have a discussion partner who keeps us informed about new trends in philanthropy. Their speed of action and expertise in legal due diligence has saved us valuable time. It's a true partnership."

Giving after life **Testamentary philanthropic funds**

Testamentary funds enable donors to plan their legacy during their life and ensure their gift will have an impact long after they are gone. They decide which beneficiaries or causes they wish to support, in accordance with their values and convictions. When the time comes, our independence and integrity guarantee that the assets in their fund will be used over several years exactly as they intended.

Three questions to a testamentary fund donor

- How do you define philanthropy?
 "Philanthropy is putting others before yourself. It's doing what you can to reduce to the number of people living in despair and poverty."
- Why did you create a testamentary fund?

 "The hosted fund concept was the missing piece in my plan for the rest of my life.

 While I'm alive, I can do what I want with the capital. I can give detailed instructions, which the Swiss Philanthropy Foundation team will carry out when the time comes. It was the right idea and the right approach."
- What was your experience of working with Swiss Philanthropy Foundation?
 "From the first conversation with them, I felt they shared my vision for what I wanted to do. After several interesting and increasingly deep discussions, I was convinced that we could do something great together. When you find the right partner, there's no hesitation!"

Maximizing impact for systemic change Collaborative funds

Giving together to rigorously selected projects Thematic funds

Thematic funds are a good option for donors starting their journey in philanthropy who want to learn from the experts, as well as experienced philanthropists looking to diversify their giving and maximize their impact. They enable donors to join forces to support high-impact projects that are rigorously selected, planned, and monitored by experts. By co-funding a project with others, donors meet peers who are passionate about the same causes and follow the implementation of a philanthropic initiative from start to finish.

 "We had the opportunity to work with Swiss Philanthropy Foundation and WISE to support girls' education in Tanzania, in partnership with a large, well-respected organization."
- What are the advantages of co-funding a project with other donors?

 "The co-funding model enabled Fondation Salève to combine our financial resources with two other donors to reach the necessary critical mass for significant impact. 
Philanthropy without borders

As TGE's representative in Switzerland, Swiss Philanthropy Foundation participated in several of the network's landmark events in 2022 and 2023, including Steering Committee meetings in Split, Croatia, in 2022, and Toledo, Spain, in 2023, and the Spring Steering Committee in Brussels, Belgium, in May 2023. These high-level events were an opportunity for the Foundation team to network with other members, discuss current and upcoming challenges, and develop a shared vision for the future of cross-border philanthropy, centred around inspiring projects made possible by this exceptional collaboration.



Donors in Switzerland




Outgoing donations from Switzerland to Europe in millions (CHF)




Incoming donations from Europe to Switzerland in 2022

Survey on the generosity of the Swiss abroad

In 2023, Swiss Philanthropy Foundation and the Organisation of Swiss Abroad jointly conducted a survey to gain insights on the charitable giving patterns of the overseas Swiss community. Administered by gfs.bern, the survey was completed by 2,583 Swiss citizens from 123 different countries. Results indicate that 90% of Swiss abroad give to charity and that 75% of these donations are in cash. The factors that motivate their giving include knowing how their donation is used and what impact it has. Solidarity is also a central value, as well as a family tradition of philanthropic giving. The survey results will help Swiss Philanthropy Foundation understand how it can better support the philanthropy of the Swiss abroad through tailored solutions that offer a good governance framework to structure their giving.



Master Class in Philanthropy

The Master Class in Philanthropy is central to the Foundation's mission. The programme and has been completed by 275 participants in French-speaking Switzerland to date. The 11th edition, in 2023, confirmed a growing interest in the programme from lawyers and finance and banking professionals who interact on a regular basis with foundations, as well as from foundation executives (board members and directors) and individual philanthropists looking to create a foundation. Twenty-five participants joined each of the 2022 and 2023 editions, held at the Château de Bossey, near Geneva. The programme provides practical tools for selecting the most suitable philanthropic structure and setting up and managing a foundation according to current and future requirements.

The Master Class is organized in collaboration with the Center for Philanthropy Studies at the University of Basel and the Centre for Philanthropy at the University of Geneva.

Verbier Festival Philanthropy Forum 2022

Swiss Philanthropy Foundation and the Verbier Festival Foundation joined forces for the 4th edition of the Verbier Festival Philanthropy Forum on the topic of "How can philanthropy be more impactful in an Age of Disruption?". Held on Saturday, 23 July 2022, at the Verbier Cinema, the event was live streamed for the first time, allowing participants to interact with speakers both in person and online. The panel included Maria Cattaui, Member of the Global Board of the Open Society Foundations; Yves Daccord, former Director of the ICRC and President of the Edgelands Institute; Jeremy Farrar, Director of the Wellcome Trust; and Beatrice Fihn, Executive Director of the International Campaign to Abolish Nuclear Weapons (ICAN).

The collaboration since 2018 between the Swiss Philanthropy Foundation and the Verbier Festival includes, in addition to this recent event, the creation of the Verbier Festival Emergency Relief Fund, established by the Verbier Festival to provide financial support to alumni of the Verbier Festival Academy during the Covid-19 pandemic.



The changing landscape of philanthropy

Activity report 22 – 23

A look back at the past two years with Sabrina Grassi, Director General of the Swiss Philanthropy Foundation.

What were Swiss Philanthropy Foundation's main achievements in 2022 – 2023?

It has been an exciting two years. We started a new strategic cycle following the pandemic, during which many new and innovative initiatives were launched. We built on this experience to continue growing the Foundation. We created 16 new funds, which aim to better serve the needs of our donors, including both individuals and foundations. That brings the total number of hosted funds established since the Foundation's creation to 91, and the average amount distributed as grants each year to CHF 30 million.

The Foundation launched a new threeyear strategy in 2022, which runs until 2025. What activities did you focus on in the past two years?

Our strategic focus has been on strengthening the reputation of the Foundation at the national and international levels, diversifying our solutions, and improving the balance in our hosted funds between individuals and family donors, on the one hand, and foundations, on the other. We launched a testamentary fund solution

and have created five so far, all of which will at some point receive a legacy donation. We also created two funds for NextGen donors and continued to advise entrepreneurs and families seeking to connect the generations around shared values. We explored innovative collaborations, like the Demaimpact Fund, which is pioneering a new model of participatory governance. In 2023, we researched the giving of Swiss citizens abroad in partnership with the Organisation of Swiss Abroad. We also managed our first mergers by absorption, another useful role of a hosting foundation. Lastly, we strengthened our European partnerships and built new relationships with banks.

Can you tell us about the values you (re)defined in the strategy?

The Foundation Board and management team reiterated the Foundation's existing values, namely, independence, integrity, simplicity, innovation, and diversity. Being able to clearly articulate our vision and values is essential to ensure our staff understand our mission and are fully committed to it.

Innovation is one of the Foundation's key values. What does that mean in practice?

The Foundation embraces an entrepreneurial and innovative approach. We aim to support donors through new solutions and services that meet the needs of their philanthropy. For example, by hiring dedicated employees to manage projects supported by hosted funds. Ensuring a positive donor experience is also part of our strategy.

How is the Foundation adapting its strategy in response to emerging challenges in philanthropy?

We are very aware of the increasing severity of the crises and social polarization facing our world and will make these a priority in 2024/25. We are working on developing new solutions for crisis situations.

In June 2023, you became President of SwissFoundations, the umbrella organization of Swiss donor foundations. What role do hosting foundations like SPF play in the foundations sector?

My nomination recognizes of the hosting foundation model as a viable alternative on par with traditional donor foundations. As president, I also represent Frenchspeaking Switzerland within the national organization. It is both a challenge and an opportunity to contribute to regulatory issues at the Swiss and international levels.

What achievement are you especially proud of in the past two years?

I am delighted that, with the help of my team and the Board, we successfully implemented new processes to create a strong basis for the Foundation's future growth. Additionally, the onboarding of many new philanthropists and foundations into our ecosystem has helped strengthen our mission and impact.


Allocation of donations 2022-2023

The future of philanthropy

Digitalizing philanthropy

More efficient services for donors

Digitalization has emerged as a key priority for the Foundation, in light of its significant growth since 2020. The main objective is to guarantee the quality of our operations by ensuring our 10 team members have the tools they need to enhance the efficiency of our services. Over the past year, we have digitalized our processes and adopted a comprehensive suite of software tools that enable us to monitor our financial flows and diverse ecosystem more effectively.

Our efforts were focused primarily on ensuring the seamless integration of these new tools. We conducted an in-depth analysis of our processes to reassess and harmonize how each task is handled. The rollout of the first "all-in-one" Microsoft tools, in June 2023, marked the start of our transition to fully digitalized operations.

We reduced the number of software we use from eight to three, thereby lessening the risk of human error during specific steps in our processes and saving valuable staff time. These changes have been enthusiastically embraced by the Foundation team.

In the next stage, the Foundation proposes to create a dedicated platform for donors to serve as an interface for collecting essential information on hosted funds. To further strengthen our data analytics, in 2024 we plan to connect all our current tools with Power BI, enabling more granular data analysis. This initiative is yet another step in our journey to continuously optimize the Foundation's internal processes and modernize our approach to philanthropy.

Empowering beneficiaries: demaimpact

The Demaimpact collaborative fund was created in response to two observations. First, that some segments of society – young people in particular – were more severely affected than others by the Covid-19 crisis; and second, that beneficiaries are rarely part of the funding decision-making process.

The first initiative of its kind in Switzerland, Demaimpact is co-funded by four foundations, including Swiss Philanthropy Foundation. It gives a group of young people from diverse backgrounds the opportunity to experience philanthropy first-hand, by joining a committee charged with selecting projects designed by and for youth, thus empowering them to play a part in shaping the world of tomorrow. Following a call for applications, 10 young people aged 18 and 30 from French-speaking Switzerland were selected. WISE organized four co-creation workshops for the group, which introduced participants to the principles of public interest and provided them with the necessary tools to select projects that address issues that are important to them. They were then given an amount to allocate as grants to projects selected using the criteria defined during the workshops.

The Demaimpact committee decided to support IdéeSport, a foundation that promotes physical activity and sport for children and young people in Switzerland to prevent various forms of addiction. A site visit will be organized for committee members to understand how existing facilities can be sustainably transformed into spaces for movement and social interaction.

The steering committee of SwissFoundations was reorganized in response to growth in the organization and new challenges in the sector. This agile transformation includes the creation of a "first-among-equals" presidency, in which Steering Committee members take turns serving as president for a one-year term. The members' expertise is further leveraged through participation in subcommittees. Kicking off this new organizational structure, Sabrina Grassi, a member of the Steering Committee since 2020, was selected to serve as the first president. As general manager of Swiss Philanthropy Foundation, she represents an important segment of the foundations sector.

Our governance and team

The Foundation Board, which meets four times a year, ensures the Foundation is managed according to its good governance charter. The Board comprised seven members at the end of 2023. It is supported by the Finance Committee, which advises on all matters relating to investment policy, processes resource allocation.

The Bureau meets once a month. The operational team overseas the day-to-day management of the Foundation and ensures that all processes are carried out promptly and efficiently. It is responsible for the administration of hosted funds and manages donor relations.

Swiss Philanthropy Foundation achieved many new milestones in 2022 and 2023. These included a series of internal workshops to discuss the values stated in our 2022 – 2025 strategy, during which we explored how independence, integrity, simplicity, and innovation are reflected in our everyday actions. We addressed several crucial questions, such as the alignment of decision-making with our values, the use of visual aids to maintain constant awareness of our values, and the nomination of team members as "values ambassadors". In 2023 we added diversity as a fifth value, following internal discussions which laid the groundwork for greater diversity and inclusion.

The highpoint of the summer of 2023 was a one-week trip to the United States for several of our team members to meet with around 15 charitable foundations, including institutions that host donor-advised funds for individuals and charities. These meetings provided an in-depth view of the main drivers of philanthropy in the United States.
